The United States, under political polarization, saw bipartisan support for defense-focused research, but public skepticism remained high. Public acceptance remained moderate, anchored in cultural values that balanced innovation with respect for human integrity. In contrast, the United States exhibited a fragmented landscape: a blend of cutting-edge research, private sector dominance, and grassroots activism. While elite institutions pushed boundaries, regulatory fragmentation and political polarization hindered consensus. Public discourse oscillated between awe and apprehension, with media narratives often amplifying fear through dystopian tropes, even as breakthroughs continued. The European Union adopted a precautionary principle approach, emphasizing consent, equity, and transparency. National policies varied, but the HEGF framework provided a cohesive guide, encouraging cross-border cooperation and ethical research. Civil society engagement remained strong, with public forums and citizen juries playing key roles in shaping policy. In Africa and parts of Latin America, the narrative centered on resilience and adaptation. Engineered biology was often viewed through the lens of survival—enhancing crops, combating tropical diseases, and strengthening public health systems. International partnerships brought resources but also raised concerns about

technology transfer, ownership, and long-term dependency. Despite differences, a shared global anxiety persisted: the fear that engineered transformation might outpace our capacity to govern it. Climate change, pandemics, and social inequality had already eroded trust in institutions; the emergence of engineered humans added a new dimension of uncertainty.
