Jung's formative years unfolded against the backdrop of two seismic shifts: the collapse of the Bretton Woods consensus in the 1970s and the subsequent rise of deregulated financial markets in the 1980s and 1990s. These decades forged a generation of bankers who learned to operate not in the era of clear rules, but in the ambiguity of regulatory arbitrage. Jung, recruited by Credit Suisse in the early 1990s as a quantitative analyst, quickly distinguished himself not through traditional trading prowess, but through his ability to model complex interdependencies—between sovereign credit ratings, currency flows, and geopolitical risk. By the late 1990s, Jung had ascended to lead Credit Suisse's emerging markets restructuring desk, a role that placed him at the epicenter of the Asian Financial Crisis, the Russian default of 1998, and the subsequent recalibration of global capital. Unlike many of his peers who viewed these events as discrete failures, Jung analyzed them through a structural lens, arguing that the crises were symptoms of a deeper imbalance: the mismatch between capital mobility and institutional resilience.
