He exploited the asymmetry between state capacity and private-sector innovation, embedding himself in the undercurrents of global data flows. His method was surgical. He did not hack armies. He infiltrated intermediaries—engineers, journalists, former intelligence officers—whose access to sensitive systems created chokepoints. Through these conduits, he monitored and traded intelligence, financial flows, and strategic communications, often bypassing formal diplomatic channels.
