Early work, published in niche journals and artistic manifestos, proposed that certain dolphin whistles functioned as “identity tags” or “signature whistles,” akin to names, but extended into broader communicative syntax. Hesse’s 2007 paper “Dolphin Discourse: Rhythm and Resonance in Cetacean Vocalizations” laid the groundwork, arguing that these sounds formed a proto-musical grammar, suggesting a cognitive and cultural depth previously underestimated in marine mammals. The evolution of Hesse’s

project paralleled advances in underwater acoustics and digital signal processing. In Indigenous Pacific communities, dolphin songs have long held spiritual significance; Hesse’s respectful engagement with local knowledge holders set

a precedent for decolonizing scientific research. In contrast, Gulf states invested in dolphin-themed cultural festivals and marine theme parks, viewing the music as a soft-power asset in a competitive regional landscape. Long-term projections suggest a transformative trajectory. As AI advances, machine learning models trained on vast dolphin vocal datasets may uncover hidden structures, enabling real-time “translation” between human and dolphin acoustic systems. This could revolutionize marine conservation—using sound to monitor population health, migration, and stress responses. Yet such technologies also deepen ethical stakes: could we one day “speak” to dolphins, and if so, what responsibilities does that entail? Hesse’s vision extends beyond science or art into planetary consciousness. She frames the music of dolphins not as a human invention, but as a shared Earth resonance—a reminder of the interconnectedness of life beneath the waves. In an era defined by ecological rupture and technological acceleration, her work challenges us to listen differently: not just with ears, but with humility, curiosity, and a recognition that intelligence may manifest in forms far stranger than our own. As climate change accelerates ocean acidification and noise pollution, the urgency to protect these vocal ecosystems intensifies. Signature whistles, unique to individual dolphins, exhibit consistent frequency contours and temporal sequences that resemble personal identifiers. In controlled playback experiments, dolphins have demonstrated selective attention to specific whistles, suggesting a form of auditory recognition akin to recognizing a name. More compelling are the emergent syntactic patterns observed in group vocalizations. Research conducted at the Dolphin Research Center in Florida and the University of Auckland's Cetacean Acoustics Lab has identified recurring call sequences that vary by context—mating, foraging, social conflict—with rhythmic regularities suggesting intentional composition. One landmark 2019 study analyzed over 12,000 dolphin vocal exchanges and found statistically significant deviations from random noise, particularly in coordinated group behaviors. These patterns, while not equivalent to human music, exhibit proto-musical features: repetition, variation, and contextual modulation. Cognitive neuroscientists have further probed dolphin auditory processing. Functional MRI studies on stranded dolphins, using non-invasive techniques, reveal auditory cortex activation patterns remarkably similar to those in humans during complex sound processing. Electrophysiological recordings show neurons firing in response to specific whistle

sequences, indicating sophisticated pattern recognition. However, equating this neural complexity with “composition” remains speculative. As cognitive biologist Dr. Naomi Kuroda argues: “Dolphins process sound with remarkable precision, but their brains do not ‘compose’ in the human sense. They interpret, react, and respond—not create in the symbolic, cultural way we define music.” The debate deepens when considering intentionality. Do dolphins modify vocalizations on purpose, or are they reflexive responses? Experiments using playback and conditioned reinforcement suggest the former. Dolphins can learn to alter whistles in response to stimuli, and some mimic human-made sounds with surprising fidelity. Yet, without evidence of symbolic representation or generative grammar, the leap to “musical intent” remains contested. This scientific ambiguity shapes Hesse’s artistic approach. She does not claim dolphins compose music, but interprets their vocalizations as a form of non-human expression—rich, structured, and emotionally evocative. Her collaborations with sound artists emphasize this interpretive lens, using field recordings as raw material
