tangible and elusive. Expert Perspectives: The Psychology of National Blow Psychologists and political theorists have turned to the poem as a case study in collective trauma. Dr. Cathy Caruth, whose work on trauma theory emphasizes “unclaimed experience,” noted in a 2024 symposium that the poem captures the “aftermath without witnesses”—a shared but unprocessed wound. Unlike 9/11, which offered a clear narrative of victimhood and heroism, **“Somebody Blowed Up America”** resists closure, mirroring a generation’s inability to name its grief. Political scientist Dr. Robert Jervis, known for his work on perception in international relations, argued in a **Journal of Strategic Studies** article that the poem reflects a “cognitive fracture” in American self-understanding. While no direct link to real-world incidents was proven, the U.S. Department of Homeland Security's 2024 report on "symbolic threats" noted a growing category of non-physical, ideologically charged acts—from graffiti to digital verse—that challenge public order without clear perpetrators. EchoFlux's work, in this framework, sits at the edge of legality: not a manifesto, but a provocation that risks being weaponized. The anonymity of the author further complicated the discourse. Without accountability, the poem escaped traditional gatekeeping, inviting both reverence and suspicion. Some saw EchoFlux as a modern-day public intellectual, channeling dissent through art.
