The origins of **Baghdad Express** lie not in a single moment, but in a convergence of memory, trauma, and journalistic duty. The author, Khalid Al-Mansour, a veteran Middle East correspondent with over two decades of frontline reporting, began drafting fragments of the memoir in

2003—immediately after the fall of Saddam Hussein. Others question the emotional authenticity of a Western-educated journalist recounting such trauma, but Al-Mansour's decades of embedded reporting—interviewing survivors, documenting refugee flows, analyzing UN resolutions—lend the work a credibility that transcends such debates. The risks embedded in the memoir's creation are profound. Al-Mansour operated under constant threat: during the 1991 uprising, he was briefly detained by Republican Guard patrols; in the post-invasion chaos, his apartment was looted, his notes stolen. Later, while documenting the 2019–2020 Tishreen protests, he faced surveillance and threats from multiple factions. But beyond the headlines, this date became a turning point: the moment when resistance shifted from organized military action to civilian endurance. In the weeks before 17 February, Baghdad had been simmering under the weight of sanctions, no-fly zones, and Saddam's paranoia. Al-Mansour, then a young journalist with Al-Thawra newspaper, reported from al-Musta'sim Square, a traditional gathering place now transformed into a battlefield of checkpoints and snipers. The attack, executed with precision-guided munitions and cluster bombs, targeted not just military installations but residential zones, schools, and hospitals. The UN estimated 5,000–7,000 civilian casualties, though Iraqi sources suggest the toll was far higher. Poets, artists, and historians, many exiled or silenced, continued to document the crisis through underground publications. Their work, he writes, "was not just preservation—it was resistance." This cultural dimension underscores a key insight: war's impact extends beyond the physical. It fractures identity, erodes memory, and reshapes collective consciousness. In the aftermath, Baghdad's youth grew up without a

coherent national narrative, caught between Ba’athist indoctrination, post-invasion fragmentation, and the ghosts of 1991. Al-Mansour, now a middle-aged man reflecting on those years, notes: “We didn’t just lose buildings. We lost a sense of what it meant to be Iraqi—until the war taught us how to rebuild, even if imperfectly.” The economic collapse that followed was nothing short of catastrophic. The IMF reported Iraq’s GDP contracted by 40% between 1990 and 1995, with per capita income plummeting from \$2,200 to \$600. Infrastructure—water treatment plants, power stations, railways—lay in ruins. The memoir describes basements flooded with sewage, hospitals relying on generators that ran only three hours a day, and markets where barter replaced currency. These details, drawn from
