World War II accelerated demand for skilled graduates, and postwar GI Bill enrollments swelled the student body. Yet, segregation persisted—Black students were barred from dorms, labs, and majors until the 1950s, when incremental legal challenges

and civil rights activism began to dismantle formal barriers. This tension between institutional progress and social inertia defined much of the university's mid-century identity.
