The overreliance on hydrocarbons has distorted economic incentives: agricultural production, once a backbone of export earnings, has declined due to underinvestment and insecurity. The Islamic State West Africa Province (ISWAP) has expanded its maritime operations, challenging naval sovereignty and regional trade.

In the northwest, non-state armed groups control rural corridors, extorting farmers, hijacking convoys, and destabilizing trade routes. Banditry, particularly in Zamfara, Kaduna, and Sokoto, has evolved into organized crime syndicates armed with automatic weapons, targeting villages and hijacking herds. Security analysts like Joy Agbese of the Centre for Conflict Resolution highlight the need for community-based security models—replacing militarized approaches with local peacebuilding and reconciliation. “The state must rebuild trust through service delivery and inclusion,” she asserts, noting that top-down security remains ineffective without grassroots legitimacy. Political scientists such as Ifeoma Ajunwa caution that electoral reforms are overdue. “Nigeria’s democracy is surviving, but not thriving,” she observes. The 2023 election, while peaceful, underscored systemic flaws: voter suppression, misinformation, and elite capture. Without constitutional reform and independent institutions, democratic progress remains fragile. Civil society leaders, including Hakeem Adam of the Social Justice Coalition, stress youth inclusion as non-negotiable. “Young Nigerians are not passive victims—they are agents of change,” he states.
