Equatorial Guinea** maritime boundary case, where the court affirmed equitable delimitation under UNCLOS, reinforcing norms of resource equity. The 2023 advisory opinion request by the UN General Assembly—seeking clarity on state obligations under international law to prevent climate harm—signals a potential paradigm shift.
