Crisis management has also adopted deflection as a defensive and offensive tool. Military and intelligence analysts, however, emphasize deflection’s operational necessity. Dr. Mary Catherine Kuhne, a former U.S. Department of Defense strategist, notes that in hybrid warfare, traditional force is often insufficient. The Stuxnet cyber operation, paired

borders. In the U.S., Section 230 protections shield platforms from liability, enabling unchecked spread of harmful content. Emerging democracies face particular challenges, lacking institutional capacity to regulate digital influence while balancing free expression. The absence of global standards leaves a governance vacuum, enabling bad actors to exploit jurisdictional gaps.

## **Global Comparisons: Authoritarian Control vs. Democratic Resilience**

Deflection psychology manifests differently across political systems. Authoritarian regimes institutionalize it through centralized media, algorithmic curation, and state-sponsored narratives. China's Great Firewall and Xinhua News Agency exemplify top-down deflection: framing dissent as foreign interference, economic success as national pride, and surveillance as security.
