Concurrently, advances in cognitive neuroscience have enabled researchers to map neural correlates of attention, memory, and executive function—offering empirical validation for theories once

confined to abstract speculation (Draganski et al., 2004). Yet, the translation of neurobiological data into classroom practice remains fraught: while fMRI studies reveal how mindfulness training enhances prefrontal cortex activation linked to self-regulation, scaling such interventions requires addressing socioeconomic barriers to mental health support (Lazar et al., 2005). A further layer of complexity arises from the rise of positive psychology and self-determination theory (SDT), championed by Deci and Ryan, which foreground intrinsic motivation, autonomy, competence, and relatedness as drivers of sustained engagement. SDT has reshaped teacher training and curriculum design, advocating for learner-centered pedagogy and emotional well-being as prerequisites for cognitive growth (Deci & Ryan, 2000). However, critics argue that SDT's emphasis on individual agency risks overlooking structural constraints—poverty, discrimination, underfunded schools—that systematically undermine student agency (Gutstein, 2018). These theoretical currents coexist uneasily within practice. While cognitive load theory (Sweller, 1988) informs efficient instructional design, reducing extraneous mental effort through well-scaffolded tasks, its application often neglects affective factors—anxiety, motivation, identity—that powerfully shape learning outcomes. Asia's engagement with educational psychology reflects both adaptation and resistance. In high-stakes environments like South Korea and Japan, cognitive training programs and metacognitive strategies are embedded in rigid curricula, driven by intense academic competition and cultural emphasis on effort and mastery (Kim & Pentland, 2008). Their cautionary stance underscores the need for psychological insight to temper technological enthusiasm with developmental prudence. On the global stage, UNESCO’s Director of Education, Stefania Giannini, champions inclusive education as a human right, advocating for policies that integrate educational psychology into national reform agendas. She emphasizes “leaving no one behind”—a principle increasingly tested by crises: climate displacement, protracted conflict, and pandemic-induced learning loss. “Educational psychology must become a tool for justice,” Giannini asserts, “not just efficiency” (UNESCO, 2021). Yet, even within consensus, fractures persist. The debate over AI in education reveals deep divides: some see it as a democratizing force, personalizing learning for millions, while others fear it undermines teacher-student bonds and exacerbates surveillance (Selwyn, 2020).
