"In contexts with weak institutions, flexibility risks being exploited—agencies adopt the 'appearance' of compliance without transforming power structures. Transparency without enforcement becomes performative." This critique resonates in countries like Venezuela, where pilot digital platforms showed AAPC-like dashboards but failed to alter entrenched rent-seeking behaviors. Legal

scholars emphasize the framework's constitutional implications.
