Brazil's Central Bank regularly references exchange rate overshooting when communicating with markets, yet acknowledges the limits imposed by fiscal indiscipline and political instability. In Turkey, recurrent currency crises have seen policymakers invoke Dornbusch logic—raising rates to counter depreciation pressures—only to face inflationary spirals that contradict the model's smooth adjustment assumption. In the Middle East, petrodollar economies like Saudi Arabia operate under implicit dollar pegs, where exchange rate stability is enforced by sovereign wealth funds and fiscal reserves. Here, the model's focus on market-driven adjustment is less applicable; instead, managed stability dominates, funded by fiscal buffers and external reserves. This global diversity underscores a key insight: Dornbusch's framework is not a universal law but a calibrated lens.
