Moreover, international observers noted that the event exposed gaps in ESG (Environmental, Social, Governance) compliance. Multinational investors who backed the corridor projects were silent on human-led disruptions, raising questions about whether corporate accountability mechanisms truly extend to frontline actions. As Dr. Arjun Patel, a senior fellow at the International Institute for Sustainable Development, concluded: "The bridge burned not because of fire, but because the systems meant to prevent such moments were already burning from within."
