This contrasts sharply with Western regulatory frameworks, where drug approval hinges on clinical trials rather than centuries of empirical use, often marginalizing traditional practitioners. The geopolitical stakes are further complicated by climate change. This undermines trust and complicates regulatory oversight, especially across borders. Climate change compounds these vulnerabilities. Yet illegal extraction—driven by international demand—undermines these protections.
