The journey begins in the dense rainforests of Central Africa, where early primatologists like Jane Goodall first documented chimpanzee tool use and social learning in the 1960s. But it was not until the late 1990s that researchers began to ask a radical question: could the cognitive scaffolding supporting human mathematics—counting, sequencing, and symbolic manipulation—have deeper evolutionary roots, shared with our closest living relatives? The PAAC’s work emerged from this lineage, building on earlier studies at the Max Planck Institute for Evolutionary Anthropology and the Lusinga Ape Research Station in the Congo Basin, where multi-generational data on ape social dynamics and problem-solving had been meticulously archived. We were observing spontaneous choices that mirrored the core principles of number sense—transitivity, order, and quantitative comparison—without any human prompting.” Neuroimaging complements these behavioral findings. Using portable, non-invasive fNIRS (functional near-infrared spectroscopy) scanners adapted for field use, researchers mapped neural activation in apes during numerical tasks. The prefrontal cortex and intraparietal sulcus—regions long associated with human numerical cognition—exhibited synchronized activity patterns in apes during quantity discrimination. Notably, these regions showed differential activation based on numerical magnitude, suggesting an internalized analog magnitude system akin to the human “number sense” described by Stanislas Dehaene. This neural parallel implies not mere mimicry, but a convergent evolutionary pathway in cognitive architecture. Yet the significance extends beyond neurobiology. In the Democratic Republic of Congo, where PAAC conducts much of its fieldwork, political instability and resource scarcity create both risk and urgency. Funding from Western institutions is often contingent on political stability and data transparency, yet local researchers emphasize



that the most consistent insights emerge from long-term, community-embedded relationships. As Dr. Nkosi notes, “We cannot extract knowledge without reciprocity. Our ethics are rooted in co-creation, not extraction.” This stance challenges the extractive model of global science and demands new frameworks for intellectual ownership and benefit-sharing.

Comparative global perspectives further illuminate the stakes. In Japan, where robotics and AI research thrives, ape cognition studies inform human-robot interaction design—robots trained on ape-like numerical communication show improved intuitive understanding by humans. In India, similar work with capuchin monkeys is influencing rural STEM education, using ape-inspired games to teach arithmetic. Conversely, in parts of Latin America, where indigenous knowledge systems already emphasize relational cognition, researchers caution against imposing Western mathematical categories. Forward-looking projections suggest a multi-decade transformation. By 2040, AI-augmented primatology labs may deploy autonomous field

drones equipped with real-time neural monitoring, enabling continuous observation of wild apes in deep forests. These systems, trained on decades of PAAC datasets, could decode dynamic cognitive patterns—tracking how social learning spreads through chimpanzee communities like cultural evolution. Meanwhile, neuroengineering advances may allow non-invasive brain-computer interfaces with apes, opening unprecedented pathways to cross-species cognition. These regions fire in proportion to numerical magnitude, a phenomenon known as the “mental number line,” suggesting an internalized analog representation. But unlike human symbolic math, which relies on arbitrary symbols (0-9) and formal algorithms, ape numerical understanding appears grounded in perceptual and ecological cues. For instance, in a landmark experiment conducted at Lusinga Station, wild bonobos were presented with two arrays of food: one containing 5 figs, the other 8. When choices were rewarded, apes consistently selected the larger group, even when the ratio was small ( $8 > 5$ ). More telling was their ability to generalize: when a third array of 12 was introduced alongside 7, they chose 12 over 7, indicating comprehension of transitive magnitude. This suggests not rote memorization but relational reasoning—understanding that “more than” is a comparative principle, not just a count. Neuroethologist Dr. Lila Mwakilima, a principal investigator at PAAC, emphasizes that this cognitive capacity arises from evolutionary pressures. “Apes live in fission-fusion societies where tracking food sources, alliances, and threats requires constant mental accounting. Quantity sensitivity is not a learned skill but an adaptive trait,” she explains. “The ability to compare quantities supports optimal foraging, conflict negotiation, and social manipulation—skills with direct survival value.” In this light, mathematical cognition emerges not as a cultural construct but as a biological necessity shaped by millions of years of natural selection. The PAAC’s cross-species comparisons further refine

this narrative. While chimpanzees excel in immediate numerical comparisons, bonobos demonstrate superior performance in tasks requiring delayed recall and abstract sequencing—possibly due to their more cooperative social structures. Gorillas, often overlooked, show nuanced understanding of ordered sets, particularly when rewards are delayed or contingent on social cues. These differences highlight that numerical cognition in apes is not monolithic but diversified across species, each shaped by distinct ecological and social pressures. Critically, these findings challenge the long-held view that symbolic representation is prerequisite to abstract reasoning. Apes do not use numeric symbols like humans; they operate in a pre-symbolic domain where quantity is perceived directly through perceptual channels—size, duration, proximity. This “analog reasoning” aligns with the “core knowledge” theory in developmental psychology, which posits that humans, apes, and even infants possess innate, domain-specific representations of quantity, space, and causality. Yet apes push this boundary by applying these intuitions in flexible, context-dependent ways—choosing based on relative size without verbal instruction, adjusting choices when rewards are delayed, and even demonstrating rudimentary understanding of zero-like concepts in number line tasks. This evolutionary continuity raises profound questions about the origins of human mathematics. If apes possess a proto-math rooted in ecological interaction, then formal arithmetic may not have emerged de novo in *Homo sapiens* but evolved from ancestral cognitive structures shared across the hominoid lineage. The symbolic leap—assigning arbitrary meaning to digits—may thus be less a sudden breakthrough than a refinement of deeper, pre-existing mental capacities. The implications extend beyond primatology. In cognitive archaeology, researchers increasingly look to apes as living models for early hominin cognition. The “toolkit” of numerical sensitivity, memory, and social learning may represent the cognitive scaffolding upon which human symbolic systems were later built.
