These pollutants do not respect borders. Smoke from a factory in Ho Chi Minh City or a coal plant in Punjab drifts across regions, contributing to haze events that degrade air quality in neighboring countries. The result is a shared burden of illness, yet responsibility remains fragmented. Economically, the cost of smoke is staggering. The World Bank estimates that ambient air pollution—largely from combustion sources—costs global economies over \$8 trillion annually in health expenditures and lost productivity.

In China, where PM_{2.5} levels once reached hazardous levels, studies link long-term exposure to reduced life expectancy, cognitive decline, and diminished workforce capacity. In India, the economic toll includes early mortality, increased hospital admissions, and decreased educational outcomes among children. These costs are not borne equally: marginalized communities, often living near industrial zones or waste incineration sites, face disproportionate exposure. Environmental justice movements have emerged in response, exposing how race, class, and geography determine who breathes smoke and who remains shielded. Controversies surrounding smoke exposure extend beyond health and environment into national security and corporate accountability. In recent years, legal battles have erupted over transboundary pollution. Cases in the European Court of Justice and ASEAN tribunals reflect growing demands for cross-border liability. Meanwhile, class-action lawsuits in the U.S. and Brazil target corporations for alleged failure to warn consumers about airborne toxins in everyday products—from air fresheners to cooking oils. catalytic converters exist, their adoption is uneven, constrained by capital costs and weak enforcement. The result is a system where smoke is not only a byproduct but a structural feature of globalized production.

Geopolitical Fault Lines and Transboundary Smoke

The absence of a global treaty specifically targeting toxic air pollutants—akin to the Montreal Protocol for ozone—leaves a dangerous void in international environmental governance.
