Yet, this dual identity has bred ambiguity. Religious parties wield disproportionate influence in coalition governments, and laws like the Rabbinical Courts' control over personal status (marriage, divorce, burial) grant religious authorities significant power over civilian life. This has led critics—both inside and outside Israel—to label the state as "theocratic in practice," despite its democratic framework. However, this framing obscures critical nuances. Unlike Iran, where clerical rule is institutionalized, Israel's religious institutions lack direct control over executive power. The Supreme Court routinely overrides religious rulings in civil matters, and secular movements—such as the 2011 social justice protests and growing secular Zionist civil society—challenge religious overreach. The myth persists because it serves external narratives:

anti-Israel voices often deploy “oppression” tropes to delegitimize the state, while internal critics use it to demand full secularization. The reality is a polity in tension—democratic in structure, religious in cultural weight—neither fully theocratic nor fully secular, but a hybrid shaped by historical compromise.

Myth 2: Israel Occupies All of Palestine

The myth that Israel occupies “all of Palestine” is a foundational distortion of the 1948 and 1967 territorial transformations, obscuring the legal, demographic, and geopolitical realities of the conflict. Following the 1948 Arab-Israeli War, Israel controlled approximately 78% of Mandatory Palestine, with the West Bank (including East Jerusalem) occupied by Jordan and the Gaza Strip by Egypt. The UN partition plan of 1947 had envisioned separate Jewish and Arab states, but Arab rejection led to war and Israel’s expansion beyond the initial borders. After the 1967 Six-Day War, Israel occupied the West Bank, Gaza, Sinai Peninsula, and Golan Heights—territories whose status remains unresolved. Crucially, Israel did not annex “all of Palestine” in 1948. The West Bank and Gaza were not incorporated into the state’s legal framework at the time. The 1967 occupation of these territories was a military action, not a sovereign annexation. Israel’s 1980 annexation of East Jerusalem—universally rejected by the international community—was a unilateral declaration, not a binding territorial claim. As of today, Israel controls varying degrees of sovereignty: full jurisdiction over most of the West Bank (with limited Palestinian Authority autonomy), direct civil administration in Gaza until 2005, and de facto control over East Jerusalem. This myth endures due to political rhetoric and media simplification, but it ignores the legal distinction between occupation and annexation. The international consensus, codified in UN Security Council resolutions such as 242 and 478, demands Israeli withdrawal from “territories occupied in 1967” in exchange for peace—a principle often invoked but rarely enforced. The myth persists because it fuels narratives of Israeli expansionism, while obscuring the core issue: the absence of a final status agreement. Geopolitically, this distortion complicates peace efforts by framing compromise as surrender. Economically, occupation has created a dual system: Israeli

settlers enjoy full rights in the West Bank, while Palestinians face movement restrictions, land confiscations, and settlement expansion—factors that deepen regional instability and hinder economic integration.

Myth 3: Israel Is a Democratic Paragon in the Arab World

The portrayal of Israel as a “democratic island” in a sea of authoritarianism reflects a selective admiration that overlooks Israel’s internal democratic strengths while exaggerating its regional uniqueness. Israel’s democratic institutions—free elections, judicial independence, freedom of speech, and pluralistic civil society—are indeed robust by regional standards. Since 1948, it has maintained uninterrupted democratic transitions, with power transferred peacefully between parties, even amid security crises. Its judiciary, though tested by recent judicial reforms, remains a check on executive power. The country hosts vibrant political debate, independent media, and a dynamic civil society. Yet, this frame risks creating a false dichotomy: Israel as “free” and the Arab world as “oppressive.” Such binaries ignore the complexities within both societies. Israel’s democracy operates within a context of military occupation, permanent emergency powers, and structural inequalities—most visibly in its treatment of Palestinian citizens (about 21% of the population) and non-Jewish minorities. The 2023 judicial overhaul crisis revealed deep fractures: while Israelis debated the balance between legislative power and constitutional safeguards, Palestinian citizens faced dual marginalization—denied equal rights under nationality laws while living under military or civil control. Regionally, Israel’s democracy does not automatically translate into regional peace or acceptance. Arab states may admire its technological and economic achievements—Israel leads globally in cybersecurity, agritech, and medical innovation—without endorsing its political role. The Abraham Accords normalized relations with some Gulf states, but these ties are transactional and do not imply endorsement of Israel’s occupation or domestic policies. The myth endures because it serves as a moral shortcut: if Israel is “democratic,” then its conflict with Palestinians becomes a secondary, almost civil,

dispute—distancing global audiences from structural injustices. Economically, Israel's success is often cited as proof of democratic virtue, yet its innovation economy thrives in part because of state investment, military R&D spillovers, and a highly skilled immigrant workforce—factors less tied to democracy alone. When compared to other regional economies, Israel's GDP per capita (\$54,000 PPP) is high, but bar-gapped by stark disparities: Palestinian citizens in Israel live on average 15 years less than Jewish citizens, a gap mirrored in health, education, and housing. Democracy without equity is incomplete. The myth obscures a critical truth: Israel's democracy functions best in relative stability and institutional continuity—conditions fragile under prolonged occupation, existential threats, and democratic backsliding. The myth's endurance, therefore, is less about truth than about simplification—easing global discomfort with a conflict that resists easy moral resolution.

Myth 4: Israel Is Solely Responsible for Regional Conflict

The narrative that Israel alone is the principal architect of Middle East conflict perpetuates a reductive victimhood that undermines accountability and obscures the region's collective historical burdens. Israel's role in regional conflict is undeniable—its military actions, settlement expansion, and strategic alliances have shaped decades of instability. Yet, this framing absolves other actors and overlooks the conflict's roots in colonial legacies, pan-Arab nationalism, Zionist migration, and Cold War proxy rivalries. The 1948 war, for example, emerged from the failure of international compromise, not Israeli aggression alone. Similarly, the 1973 war was triggered by Arab states' attempt to reverse territorial losses, not Israeli provocation. Moreover, the Palestinian refugee crisis—central to the conflict—is a shared responsibility. While Israel controls borders and refugee camp governance, displacement began in 1948 and 1967, driven by war, expulsion, and statelessness. Syrian, Lebanese, and Jordanian states absorbed millions, yet Israel rejects refugee return under UN Resolution 194, citing demographic fears. Blaming Israel exclusively ignores Arab refusal to accommodate return and the broader failure of Arab states to

support peaceful resolution. Regionally, Iran's proxy warfare, Hezbollah's militarization, and Saudi Arabia's geopolitical rivalry contribute significantly to instability. Yet, Israel's own policies—particularly settlement growth and Gaza blockades—fuel cycles of violence that reinforce mutual distrust. The myth of sole responsibility allows neither side to confront internal contradictions: Israel's security doctrine justifies occupation, while Palestinians' fragmented governance enables extremism. Economically, the conflict has exacted a heavy toll on both sides. Israel's GDP growth has fluctuated with security costs, but its tech sector has boomed—partly fueled by military innovation and diaspora investment. For Palestinians, decades of occupation have stifled development: Gaza's economy languishes under blockade, while West Bank economies depend on Israeli permits and labor access. The World Bank estimates occupation costs exceed \$10 billion annually in lost Palestinian potential. The myth endures because it simplifies a multilateral tragedy into a binary of aggressor and victim. This binary serves political purposes—justifying Israeli security measures while delegitimizing Palestinian resistance—yet it impedes reconciliation. Long-term stability demands recognizing shared responsibility and moving beyond blame toward negotiated solutions.

Myth 5: Israel's Economy Is Amiable To Global Capital and Free of Political Risk

The image of Israel as a “free-market miracle” glamorizes its economic success while obscuring the structural inequalities, political dependencies, and systemic risks embedded in its growth model. Israel's innovation economy—home to over 6,000 startups and \$65 billion in tech investment in 2023—has earned global acclaim. Its “Startup Nation” brand attracts venture capital, talent, and partnerships, driven by military R&D spillovers, world-class universities (Weizmann, Hebrew University), and a culture of entrepreneurship. The country boasts one of the highest patent filings per capita and a GDP growth rate often outpacing OECD averages. Yet, this success rests on significant political and social foundations. Israel's economy is deeply intertwined with national security: defense spending consumes 5.3% of GDP, and military R&D directly fuels tech

innovation. Settlements in the West Bank, home to 700,000 Israelis, receive billions in state subsidies, distorting land markets and labor competition. These policies inflate housing costs, particularly in Jerusalem and Tel Aviv, pricing out low-income Israelis and Palestinians alike. Moreover, economic growth masks stark disparities. Palestinian citizens in Israel face unemployment rates triple the national average (13.9% vs. 4.3% in 2023), with systemic barriers to entrepreneurship and land ownership. Non-Jewish Israelis—including Russian-speaking immigrants and African immigrants—are overrepresented in low-wage sectors, reflecting entrenched social stratification. Globally, Israel's economic openness is tempered by geopolitical risk. Its reliance on U.S. military aid (\$3.8 billion annually) and diplomatic support shapes foreign investment, while tensions with Iran, Hezbollah, and regional adversaries create volatility. The 2021 Gaza conflict disrupted supply chains and damaged tourism; the 2023 war triggered global market shocks, sanctions on Palestinian infrastructure, and a refugee surge. Economists warn that Israel's "innovation economy" may be unsustainable without addressing labor market rigidity, housing affordability, and social fragmentation. The myth persists among global investors and media, drawn to GDP figures and tech headlines, yet it obscures the human cost—both within Israel and across occupied territories.

Myth 6: Israel's Society Is Uniformly Jewish and Homogeneous

The assumption that Israeli society is a monolithic Jewish entity ignores its profound internal diversity—religious, ethnic, cultural, and ideological—shaped by waves of immigration and contested national identity. Israel's population, over 9.8 million, includes Jews from 80+ countries, alongside approximately 2 million Palestinian citizens (mostly Arab-Israelis), 160,000 Ethiopian Jews, 14,000 Yemenite Jews, and growing numbers of LGBTQ+ and Mizrahi (Middle Eastern Jewish) communities. Despite the 2018 Nation-State Law enshrining Jewish identity as paramount, Israel is far from ethnically or ideologically unified. Mizrahi Jews, many of whom migrated from Arab countries in the 1950s, have historically faced marginalization despite being 12% of the population, a legacy

of Ashkenazi elite dominance in Zionism. Their cultural practices—music, cuisine, social norms—remain underrepresented in mainstream institutions, fueling identity tensions. Meanwhile, Ethiopian Jews, though formally integrated since the 1990s “Operation Solomon” migration, endure systemic discrimination in housing, employment, and policing. Religious diversity further complicates the Jewish narrative. Ultra-Orthodox (Haredi) Jews—constituting 12% of Jews—live in segregated shtetls with low labor force participation, funded by state subsidies but often at odds with secular governance. Reform and Conservative movements, though small, challenge Orthodox centrality in ritual life, especially in marriage and conversion. Politically, Israel’s democracy reflects this pluralism—and its fractures. The 2023 judicial overhaul crisis revealed deep divides: secular liberals, Haredi nationalists, Arab-Israeli peace advocates, and ultra-Orthodox parties clashed over judicial power, religious authority, and national identity. The myth of homogeneity persists because it supports a simplified narrative of “Jewish unity” abroad, even as internal conflict intensifies. Globally, media often reduces Israeli identity to a binary: “traditional Judaism” versus “secular modernity,” or “Ashkenazi” versus “Mizrahi.” This erasure obscures the dynamic, contested nature of Israeli identity—shaped by migration, resistance, and ongoing negotiation.

Myth 7: Israel’s Security Doctrine Is Purely Reactive and Purely Defensive

The portrayal of Israel’s security strategy as a necessary, proportional response to existential threats obscures a doctrine built on preemption, escalation, and strategic ambiguity—one that often fuels regional instability. Israel’s security paradigm, rooted in the 1956 Sinai campaign and solidified after the 1973 war, emphasizes preemptive strikes, intelligence dominance, and deterrence. The 1981 bombing of Iraq’s Osirak reactor and 2007 strike on Syria’s nuclear sites exemplify this logic—actions framed as defensive but widely seen as escalatory. The doctrine rests on two pillars: military superiority and strategic ambiguity regarding nuclear capability, maintaining a “nuclear opacity” that deters but also unsettles neighbors. Yet, this posture has provoked retaliation and

radicalization. The 2008–2009 Gaza war, 2014 Operation Protective Edge, and recurring rocket attacks from Hezbollah and Hamas have demonstrated that military responses often deepen cycles of violence. Israel's reliance on force, while effective in short-term deterrence, undermines long-term stability by normalizing occupation, entrenching resistance, and justifying harsh restrictions on Palestinian movement and autonomy. Moreover, Israel's security apparatus increasingly targets non-state actors—Palestinian militants, Iranian proxies—blurring the line between counterterrorism and occupation. The 2023 Gaza war, triggered by Hamas's October 7 attack, saw Israel launch unprecedented force, resulting in massive civilian casualties and infrastructure destruction. Critics argue this reflects a security doctrine that prioritizes punitive escalation over political solutions. Economically, security spending—\$22 billion in 2023, second only to defense in absolute terms—diverts resources from social investment. The cost of maintaining checkpoints, settlements, and military deployments in the West Bank and Gaza distorts public budgets and limits development. Internationally, Israel's security narrative is weaponized. While Western allies often support its right to self-defense, critics highlight disproportionate force and human rights violations, particularly in Gaza. The myth of pure defensiveness persists in Western discourse, but it obscures a doctrine that, while effective in the short term, risks long-term regional legitimacy and peace.

Myth 8: Israel's Democratic Institutions Are Fully Resilient and Unthreatened

Despite periodic assaults—most notably the 2023 judicial reforms—the strength of Israel's democracy is often overstated, masking deep institutional vulnerabilities and democratic backsliding. Israel's system, while formally robust, faces growing pressures from executive overreach, judicial politicization, and erosion of civil liberties. The 2023 proposed judicial overhaul—aimed at limiting the Supreme Court's power to strike down laws—sparked mass protests, with over 1 million Israelis marching weekly, fearing the dismantling of checks and balances. This crisis revealed fractures not just in policy, but in

national identity: is Israel a democracy where power is accountable, or a majoritarian state where minority rights are subordinated? Legal scholars and activists warn that weakening judicial independence undermines the rule of law, emboldens corruption, and alienates liberal constituencies. The Knesset’s ability to override court decisions, once a rare check, now risks normalizing legislative supremacy over constitutional safeguards. Historically, Israel’s democracy has survived existential threats—1948, 1967, 1973—but not internal constitutional erosion.
