Rather than relying solely on ad-driven traffic, Sapir and Englard cultivated partnerships with academic institutions, think tanks, and forward-thinking corporations seeking narrative foresight. Yet this transformation was not without friction. Critics argued that the blending of AI-generated narrative with human input blurred ethical boundaries, risking the manipulation of collective emotion under the guise of insight. Others warned of the homogenizing potential of a global myth framework, potentially marginalizing dissenting voices in favor of consensus narratives.

Expert Perspectives: The Science and Soul of Narrative Intelligence
