In South Asia, the Mughal Empire (1526-1857) exemplified syncretic yet contested sacred geography. Akbar's construction of the **Ibadat Khana** in Fatehpur Sikri as a house of worship for multiple faiths signaled an attempt at pluralistic governance, yet his successors reimposed orthodox Islam, sparking sectarian tensions. The 1526 Battle of Panipat, where Babur defeated Ibrahim Lodi, was framed by chroniclers as divine approval,

sanctifying Mughal rule through martial victory. Later, the Sikh Golden Temple in Amritsar became both a spiritual center and a target—most infamously destroyed in 1984—demonstrating how sacred sites can be both anchors of identity and flashpoints of conflict.
