Introducing engineered microbes or non-native species—even with good intentions—can disrupt native communities, accelerate invasive species spread, or alter nutrient cycling in unpredictable ways. forest soils beyond the trial zone, sparked international debate and calls for stricter biosafety frameworks. Ethical dimensions extend to governance. Who decides which ecosystems are “restored,” and according to whose values? In many Global South nations, top-down restoration projects driven by Northern labs or corporations have been criticized as neo-colonial, imposing foreign ecological visions without local consent. This has fueled demands for decolonized science—models that integrate traditional ecological knowledge, respect biocultural rights, and prioritize community-led outcomes. Economic risks also loom. The high cost of lab-based restoration—ranging from \$5,000 to \$20,000 per hectare—may limit accessibility, favoring wealthy nations or corporate clients. Projects like the Amazon Succession Observatory integrate satellite data with local Indigenous stewardship, using lab simulations to test agroforestry models that blend traditional swidden practices with modern soil science. In Sub-Saharan Africa, labs such as RegenGen's Nairobi hub focus on arid and semi-arid lands, where climate variability threatens food security. Their work centers on drought-tolerant pioneer species, soil moisture retention via engineered microbial mats, and community-led monitoring using mobile apps. These efforts highlight the critical role of local adaptation and participatory science. In contrast, China's approach reflects centralized planning and state-driven ecological ambition. The National Ecological Restoration Laboratory in Beijing coordinates nationwide initiatives, from desert greening to Yangtze River recovery, using AI-driven succession models to simulate outcomes across biomes. This top-down model enables rapid deployment but faces criticism for limited public input and ecological homogenization. These divergent trajectories underscore a central tension: whether succession labs serve universal scientific ideals or localized, culturally grounded restoration.
