verification, embedding residency into digital travel infrastructure. This evolution reflects a broader geopolitical logic: in an era of transnational risk—pandemics, climate displacement, economic instability—residency is no longer a static status, but a dynamic, verifiable attribute. It enables states to project administrative sovereignty across populations, especially in contexts of migration flux and digital transformation.

Geopolitical and Economic Drivers: Sovereignty, Labor, and Capital

In 2021, a hack of a German health registry exposed millions of residency-linked medical records—potentially weaponized for identity theft or targeted discrimination. Legal challenges are mounting. In the European Court of Human Rights, cases like *M.S.S. v. Belgium and Greece* (2011) have condemned systemic failures to protect vulnerable migrants, citing proof-of-residency barriers as contributing factors. - **Global Standards:** Multilateral agreements to harmonize cross-border verification, preventing exclusion at borders.
- **Public Trust:** Engagement with civil society and affected communities to co-create systems that serve, not surveil.
