However, this model also introduces opacity—financial transparency is limited, raising questions about accountability and performer rights.

Geopolitically, the Freak Hunters' itinerant performances target regions where state institutions have collapsed or lost legitimacy. In post-conflict zones such as eastern Ukraine, parts of the Sahel, and the Philippines' typhoon-battered coasts, their shows function as informal public forums. By performing in abandoned schools, refugee camps, and community centers, they engage populations disconnected from formal cultural infrastructure.
