A 2020 investigation by BIRN (Balkan Investigative Reporting Network) revealed that Sulejmanovic's holding company structure

included over 17 registered entities across tax havens, with nominee directors obscuring ultimate control. While legally compliant in each jurisdiction, the complexity of ownership chains mirrored broader trends in global finance—where legitimacy is maintained through procedural adherence rather than transparency. This model, while effective for capital mobility, raised ethical questions about the separation of economic power from democratic oversight. Expert analysis frames Sulejmanovic's career as emblematic of a new class of post-conflict capitalism—one that thrives not on state patronage alone, but on exploiting institutional vacuums. Dr. Mira Petrović, professor of political economy at the University of Zagreb, notes: 'He didn't just adapt to the post-war order; he redefined its operational logic. Where others saw chaos, he saw arbitrage—between law and loophole, between local need and global capital.'
