The return of indigenous remains—often scattered in private collections or foreign museums—has become a diplomatic issue. In 2019, a California museum returned 47 Native American skeletal remains to the Tohono O'odham Nation, a rare victory in the bone trade's

shadow economy. Yet such cases remain exceptions. Global museums and auction houses continue to profit indirectly, with provenance checks often superficial. The book argues that without binding international standards, repatriation remains a symbolic gesture, not systemic justice.
