Since the early 2010s, Beijing has poured billions into national initiatives like the “New Generation AI Development Plan,” targeting self-sufficiency in core biotechnologies. State-backed ventures such as BGI Genomics and Insilico Medicine's Shanghai outpost leverage vast genomic datasets and high-performance computing clusters to accelerate protein design for therapeutics and industrial enzymes. The U.S., in contrast, has relied on a more decentralized ecosystem—Silicon Valley's venture capital fueling startups like Generate Biomedicines and ProteoLogic, while academic powerhouses at MIT, Stanford, and the Broad Institute drive foundational research. The European

Union, through Horizon Europe and initiatives like the European Protein Engineering Initiative, emphasizes ethical governance and open science, seeking to balance innovation with biosafety. Economically, the stakes are monumental.
