The Paradox of "Happy Endings": Margaret Atwood's Literary and Cultural Reckoning

In 2019, Margaret Atwood, already a titan of speculative fiction and cultural commentary, published a novel titled **The Happy Endings**. On first glance, the title struck a jarring dissonance. Atwood, whose work has long dissected dystopia, ecological collapse, gendered violence, and systemic decay, offered readers a promise of resolution so stark it felt almost subversive.
