In authoritarian regimes, its use in psychological evaluations of detainees or political dissidents raised alarms among human rights organizations, who noted its vulnerability to misuse: a distorted response due to trauma, stress, or cultural unfamiliarity could be misinterpreted as cognitive incapacity, legitimizing discriminatory treatment. In contrast, in high-stakes labor markets like South Korea and Singapore, the test persists in elite recruitment pipelines, where cognitive efficiency is conflated with future success. In China, state-backed initiatives have integrated Bender-style assessments into vocational training systems, framed as tools to match individual capability with national economic goals—raising concerns about state surveillance and social sorting. Long-term implications demand urgent attention. As artificial intelligence and neuroimaging advance, the Test de Bender’s relevance hinges on whether it evolves beyond its motor-cognitive roots. Some researchers envision hybrid models—combining Bender tasks with EEG or eye-tracking data—to create multi-dimensional cognitive profiles. Others warn against technological fetishization: “We risk automating bias,” warns Dr. Amara Nkosi, a Kenyan cognitive anthropologist. “No tool should reduce a person to a sequence of lines and timing. Over time, its utility in school-based diagnostics solidified its place in developmental psychology, yet its rigid format and reliance on motor execution limited its broader applicability. By the 1960s and 1970s, as globalization accelerated workforce demands and bureaucratic systems grew more data-driven, interest surged in tools that could rapidly assess functional capacity beyond IQ. The Bender’s simplicity—minimal equipment, clear scoring criteria, and tangible output—made it an attractive candidate. Early adaptations appeared in occupational medicine, where employers sought quick indicators of a worker’s ability to follow instructions, maintain focus, and execute precise hand movements—skills deemed essential in manufacturing, clerical, and

The rationale was pragmatic: in high-volume processing environments, a brief, visual task offered a "quick check" of cognitive function, supplementing traditional language and educational assessments. However, this application exposed a critical flaw: motor performance varied widely with language proficiency, cultural familiarity, and physical dexterity—factors unrelated to cognitive ability. A migrant with exceptional problem-solving skills but limited English might fail not due to cognitive deficit, but due to test design bias. Parallel developments in military and security screening further entrenched the Bender's adult use. The U.S. Department of Defense, amid Cold War anxieties and expanding personnel evaluations, adopted Bender-based assessments to screen recruits for perceptual attentiveness, reaction time, and stress resilience. These applications emphasized speed and consistency, often at the expense of diagnostic depth. The test's structured, time-bound nature lent itself to automated scoring, appealing to institutions seeking scalable, "objective" measures. Yet, experts soon noted that performance was heavily influenced by anxiety, fatigue, and motor skill—factors that confounded interpretations of cognitive capacity. This period also saw the first attempts at standardization. The geopolitical context of the Cold War amplified the test's global diffusion. In post-colonial states with underdeveloped educational infrastructures, the Bender was sometimes imported as a "neutral" tool for identifying learning disabilities—yet its deployment often ignored local pedagogical traditions and linguistic diversity. In some cases, it became a proxy for cognitive worth, used in state-led integration programs that marginalized individuals failing the test. Human rights observers documented instances where Bender results contributed to exclusion from education and employment, particularly among indigenous and rural populations. By the 1990s, the Test de Bender for Adults had become embedded in immigration vetting, corporate screening, and forensic evaluations—yet its scientific validity remained contested. Cognitive neuroscientists critiqued its reliance on motor execution, arguing that it conflated physical dexterity with cognitive ability. Meanwhile, industry stakeholders defended its utility, citing efficiency and cost-effectiveness. The debate intensified as digital technologies enabled new adaptations: touchscreens, eye-tracking software, and algorithmic scoring. In contrast, Scandinavian nations have largely abandoned it in favor of dynamic, interactive cognitive tasks that reflect real-world problem-solving. The divergence underscores a deeper tension: whether assessment should
