In sub-Saharan Africa, where reproductive health systems strain under dual burdens of infectious disease and rising non-communicable conditions, fibroids often go undiagnosed until advanced stages. Limited imaging infrastructure, underfunded clinics, and cultural stigma around uterine pathology delay intervention, transforming a manageable condition into a source of disability and economic loss. Meanwhile, in high-income Western nations, the biomedical

The industry landscape reflects this imbalance. The global myoma market, valued at over \$2.3 billion in 2023, is dominated by pharmaceutical companies marketing hormonal agents and injectables. These products generate steady revenue but do not address root causes. In contrast, the nutraceutical and functional food sectors—projected to exceed \$300 billion by 2030—have begun to pivot toward preventive health, yet fibroid-specific formulations remain niche and under-researched. Major supplement brands now tout “uterine wellness” blends containing curcumin, omega-3 fatty acids, vitamin D, and magnesium, but clinical validation is sparse, and regulatory oversight varies widely across jurisdictions. This commercial vacuum leaves patients navigating a fragmented landscape: self-diagnosis via online forums, anecdotal testimonials, and a medical establishment slow to integrate dietary evidence into practice. From a biochemical standpoint, fibroids thrive in an environment of hormonal excess, particularly unopposed estrogen. Estrogen promotes smooth muscle proliferation and angiogenesis, creating a fertile ground for tumor growth. The gut microbiome, increasingly recognized as a metabolic organ, modulates estrogen metabolism via the enterohepatic circulation—dysbiosis can impair estrogen clearance, prolonging its uterine exposure. Fiber’s role is twofold: it binds excess estrogen in the gut, reducing reabsorption, and fosters a diverse microbiome that optimizes hormonal clearance. Similarly, high intake of cruciferous vegetables—broccoli, kale, Brussels sprouts—delivers indole-3-carbinol, a compound that promotes estrogen metabolism toward less mitogenic pathways. Pilot programs in Scandinavia and parts of Canada now integrate multidisciplinary care teams, including dietitians, into fibroid management, linking dietary counseling with symptom tracking apps and biomarker monitoring. Early results suggest reduced reliance on surgery and improved quality of life, with projected 20–30% savings in long-term healthcare costs. Controversies persist, particularly around supplementation risks. These patterns reflect holistic models that integrate diet, herbal medicine, and lifestyle—approaches increasingly studied in integrative oncology. In contrast, Japan’s emphasis on fermented foods and green tea aligns with lower fibroid incidence, suggesting cultural dietary habits may confer protective effects. These global variants challenge the Western monoculture of medical intervention, inviting reconsideration of culturally embedded preventive strategies. These findings suggest that the biological propensity for uterine smooth muscle proliferation existed in antiquity, yet its frequency and severity appear dramatically altered in contemporary populations. The shift from sporadic occurrence to widespread prevalence correlates with key transitions in human history: the advent of agriculture, industrialization, urbanization, and dietary transformation. Early hunter-gatherer societies, with diets rich in fiber, low in processed carbohydrates, and high in polyphenols, exhibited minimal evidence of fibroids. This contrasts sharply with the 20th-century surge in diagnoses, particularly among women of reproductive age. The epidemiological transition—characterized by reduced infectious disease and increased chronic conditions—created fertile ground for hormonally driven pathologies. From an evolutionary perspective, fibroids may represent a maladaptive response to persistent estrogenic stimulation. In ancestral environments, reproductive cycles were spaced by several years, limiting prolonged estrogen exposure. Today, early menarche, extended reproductive years, and delayed childbearing amplify cumulative estrogen load—a key fibroid promoter. Moreover, the rise of endocrine-disrupting chemicals (EDCs) in food packaging, plastics, and pesticides introduces exogenous hormonal signals that perturb endogenous regulation. Bisphenol A (BPA), phthalates, and parabens mimic estrogen, binding to receptors and stimulating smooth muscle proliferation independently of natural hormone cycles. This evolutionary mismatch—between ancient physiology and modern environment—underscores why fibroids are not merely a reproductive issue but a

marker of broader ecological and societal stress. A 2022 study in **JAMA Network Open** projected that a nationwide dietary shift—aligning with high-fiber, anti-inflammatory patterns—could reduce fibroid-related expenditures by 25–30% over a decade. Yet such policies remain underfunded, overshadowed by pharmaceutical lobbying and surgical device markets. Industry influence further distorts priorities. The global myoma treatment market, dominated by hormonal agents and minimally invasive devices, generates over \$2.3 billion annually. Major pharmaceutical firms invest heavily in progestins, GnRH agonists, and injectables like GnRH antagonists, which suppress estrogen but carry significant side effects and high costs. Supplement manufacturers, by contrast, operate in a loosely regulated space, marketing “fibroid support” blends with limited clinical backing. This commercial fragmentation impedes cohesive public health strategies, even as evidence mounts for dietary modulation.

Expert Consensus and Clinical Controversies: From Suppression to Supplementation

The medical establishment’s response to fibroids has long emphasized symptom control

and structural intervention. Gynecologists typically recommend hormonal suppression—oral contraceptives, levonorgestrel intrauterine systems—when surgery is not feasible.
