'We've reached 50,000 children in rural India—those who'd never see a specialist otherwise,' he says. 'But we're not replacing therapists; we're extending their reach. The key is training local health workers to use these tools, embedding therapy into everyday life.' Patel's model reflects a growing consensus: technology's power lies in its ability to amplify, not substitute, human expertise. Yet, skepticism persists. Dr. Maria Fernandez, a critical linguist at the University of Barcelona, warns against over-automation: 'Language is not

just sound—it’s identity, history, emotion. Reducing speech to data points risks erasing the cultural and psychological layers that therapy must honor. We must ask: who defines 'correct' speech? What happens to dialects, accents, and non-native fluency in this algorithmic gaze?' Her research highlights how biased training data can pathologize linguistic diversity, reinforcing monolingual norms. 'We need not just inclusive tech, but inclusive epistemologies—valuing all ways of speaking.' These expert voices converge on a singular insight: the future of speech therapy is not predetermined by technology, but shaped by choices. Will we prioritize scalability at the cost of empathy? Will access be expanded through innovation, or deepened by exclusion? The answer lies in how we balance evidence with ethics, efficiency with equity, and machine precision with human heart.
