The 1960s and 1970s brought waves from the Caribbean and South Asia, introducing Hindi, Punjabi, and Arabic into urban centers like Toronto and Vancouver. By the 1990s, immigration from Africa and the Middle East added Swahili, Somali, and Kurdish to the mosaic. Yet French remained the sole other official language, confined largely to Quebec and New Brunswick, where it enjoys constitutional status. This asymmetry reflects Canada's federal structure: language policy is shared but unevenly applied, with provinces holding primary jurisdiction over education and public services. The constitutional moment of 1982—the Constitution Act, 1982—marked a pivotal shift. Section 133 affirmed English and French as equal languages of government, mandating their use

in federal statutes, courts, and public services. However, the act did not create a federal language agency or enforcement body, leaving compliance voluntary. The Supreme Court of Canada later clarified in cases like *\*Skiold v. Quebec\** (2009) that federal obligations extend to ensuring meaningful access, not just symbolic presence. Still, disparities persist: federal institutions in English-dominant regions maintain higher French capacity, while Quebec's federal offices enforce bilingualism rigorously. Language policy evolved further with the 2019 [Bill C-58](#) of the Official Languages Act, which strengthened mandates for federal service delivery and introduced digital accessibility standards. Yet critics argue enforcement remains weak. A 2022 report by the Office of the Commissioner of Official Languages found only 62% of federal departments met bilingual service targets, with Indigenous languages largely excluded from the framework.
