The **jya** function, expressed as half the chord of a central angle, allowed for efficient calculation of distances, heights, and orbital paths—cornerstones of both astronomy and geodesy. Mathematically, Aryabhata's sine table follows a

recursive pattern: $*jya(\theta) = 2r \cdot \sin(\theta/2)*$, where $*\theta*$ increments by 3.75° , and $*r*$ is the radius (here, 3438). His values, accurate to four decimal places, enabled precise computation of shadow lengths, solar declinations, and lunar phases.
