The Tel Dan Inscription and the Mesha Stele (Moabite) preserve early Israelite forms, revealing consonantal roots like *š-m-d* (“name,” “name of God”), *’-l-h* (“to speak, to bless”), and *’-r-’* (“high place,” “holy place”). These lexical markers align with what one would expect in a theocratic oral tradition—precisely the milieu Moses would inhabit.

The Merneptah Stele (c. 1208 BCE), the earliest known mention of “Israel,” uses a Canaanite verb root *’-l-h* in a territorial context, suggesting that by this period, a distinct cultural and linguistic identity—distinct from Egyptian or Mesopotamian—was emerging among groups in the southern Levant. Others suggest that early Israelite speech was not a single dialect but a diglossic mix—Hebrew for sacred use, a colloquial Canaanite for daily life, with Ugaritic influences in liturgical poetry. The Dead Sea Scrolls, though centuries later, preserve linguistic diversity, including archaic Hebrew forms that may reflect older speech patterns. A significant contention arises from the Septuagint (Greek translation of Hebrew) and Samaritan Pentateuch, which preserve linguistic features consistent with a pre-exilic Hebrew, possibly closer to Moses' time. The Samaritan tradition, maintaining a distinct Hebrew script and ritual, claims linguistic continuity back to the patriarchs and Exodus, reinforcing the idea of a stable, sacred tongue.
