China's approach represents a starkly different paradigm—one where state-led digital transformation fuels rapid, centralized development of medical AI. Under the “Healthy China 2030” initiative, the government has prioritized AI-driven diagnostics as a pillar of national health modernization. State-backed platforms, such as the National Clinical Decision Support System, deploy proprietary algorithms trained on vast, centralized datasets encompassing millions of patients. These systems are embedded into provincial hospitals, rural clinics, and telehealth networks, enabling nationwide deployment with remarkable speed. The Chinese model benefits from unified data policies, centralized funding, and a culture of state-directed technological advancement—allowing algorithms to evolve through continuous real-world feedback loops. However, this efficiency raises profound concerns about surveillance, data sovereignty, and clinical autonomy. The absence of robust independent oversight, combined with limited transparency around algorithmic design, fuels skepticism both domestically and internationally. Beyond these three poles, emerging economies navigate a precarious middle ground. India, for instance, has embraced lightweight, mobile-optimized algorithms to extend diagnostic reach in underserved

regions, leveraging transfer learning to adapt global models to local disease patterns—such as tuberculosis and diabetic retinopathy. Yet infrastructure gaps, inconsistent EHR adoption, and uneven digital literacy constrain scalability. Brazil and South Africa experiment with hybrid models, integrating AI into primary care while grappling with regulatory fragmentation and public mistrust. The geopolitical competition extends beyond national borders.
