Room 525 was refurbished with mid-century modern furnishings—teak desks, sculptural lamps, and muted velvet sofas—balancing reverence for heritage with contemporary functionality.

This renovation, led by preservation architect Annabelle Reyes, was controversial: purists lamented the loss of original woodwork, while developers argued it was essential to compete with emerging boutique hotels. Geopolitical Echoes: From Diplomatic Sanctuary to Surveillance Frontier
