These disputes reveal the lectionary's function not just as a religious text, but as a battleground for ecclesial power and cultural legitimacy. Geopolitical context further shapes lectionary development. In Latin America, liberation theologians have advocated for readings emphasizing the preferential option for the poor—Gospels of Jesus' encounter with the marginalized, parables of justice. In contrast, conservative regimes in parts of Africa and Asia often favor liturgical cycles aligned with state-sanctioned religious norms, suppressing readings that challenge political authority. In China, where Catholic worship operates under state oversight, the lectionary is carefully curated to avoid overtly subversive themes, illustrating how ritual texts become instruments of political negotiation. The long-term

implications of these trends are profound. The lectionary, once a fixed point of unity, is evolving into a polyvocal, adaptive medium—capable of both preserving tradition and enabling innovation. Yet this flexibility demands renewed theological rigor. As Dr. Carlos Mendoza, a Jesuit liturgical theologian, cautions: ‘To remain relevant, the lectionary must resist commodification and fragmentation.
