Legal scholars have dissected the film's interrogation of provenance law. ethical accountability, they warned against using art as a proxy for political blame. “We must preserve context, not weaponize trauma,” argued Dr. Isabelle Dubois, director of Paris’s Musée du Quai Branly. “*Oscar et la Dame Rose* risks oversimplifying complex histories into symbolic battles.” These tensions underscore the film’s power: it does not offer resolution but provokes sustained dialogue—one that bridges academic rigor, institutional critique, and public conscience.
