Over-reliance on testing can entrench a culture of anxiety, limit pedagogical diversity, and distort educational priorities. Moreover, algorithmic bias in emerging digital assessments threatens to amplify existing inequities, particularly for students from non-native English backgrounds or with learning differences. The 2024 controversy over an AI grading tool used in several London secondary schools—later found to systematically downgrade essays from working-class students—exemplifies these dangers. From a policy standpoint, the long-term implications are profound. Without systemic reform, the UK risks producing a generation of “tested but unprepared” young people—proficient in narrow benchmarks but ill-equipped for complex, evolving challenges. Conversely, a more holistic, equitable assessment system could unlock latent talent, foster lifelong learning, and strengthen social cohesion. Forward-looking projections suggest a critical juncture. By 2030, demographic shifts—including rising diversity,

climate-driven disruptions, and automation—will demand a redefined skill set. The current test book, rooted in 20th-century industrial logic, may prove inadequate. Academic David Hulme’s research on “assessment regimes” identifies this period as a key inflection point. He argues that the UK’s shift mirrored global neoliberal trends—where assessment became a tool of governance, not just education. Schools were
