Origins in the Crucible of Displacement Bessie Head's life trajectory was itself a microcosm of the trauma she rendered so vividly in *Maru*. Born in 1937 in

Pietermaritzburg, South Africa, she was classified as Coloured under the apartheid regime, a category that denied her full citizenship while exposing her to systemic marginalization.
