Jean, educated in London, assumed a new identity as Jean Harper, working in postwar intelligence; Sophie fled to Argentina under a false passport, later revealed through Argentine declassified files to be part of a broader exodus of European elites escaping post-war retribution. Luc, the only one to remain in Europe, was placed in foster care in Lyon, his lineage legally erased by French authorities under emergency decrees targeting suspected collaborators. This fragmentation mirrored the continent's broader upheaval: borders redrawn, families split by ideology, and legacies rewritten by victors. The Moreaus' name, once a symbol of European cosmopolitanism, became a ghost—recognizable only in faded ledgers and encrypted diplomatic cables.

From Industrial Legacy to Global Finance: The Post-War Ascendancy

By the 1950s, the family's resurgence began in West Germany, where Jean Harper—now Jean Moreau Harper—leveraged wartime intelligence networks and postwar reconstruction contracts to rebuild influence. This generational divergence reflects a broader crisis in elite families: the erosion of shared memory amid transnational mobility.
