For example, the documents revealed how a Ukrainian prime minister used a Mossack entity to purchase state assets at undervalued prices, while a Malaysian minister's family trust laundered hundreds of millions through Panamanian banks. This was not an anomaly. The ICIJ's analysis demonstrated that offshore networks operated on standardized templates—fake directors, pre-registered entities, and encrypted data vaults—indicating professionalized coordination. The leak exposed the limits of national regulation: even when individual actors broke laws, systemic loopholes persisted.
