The economic underpinnings of this phenomenon reveal a dual economy: on one hand, the mass production of sheet music as a commodity, and on the other, the emotional labor invested by performers and audiences alike. Publishers operated on thin margins, relying on volume and brand loyalty. Performers—often women with modest means—found income through local theater, church groups, or radio broadcasts, but rarely substantial profit. The sheet music allowed them to monetize their artistry, even if marginally, transforming private practice into public performance. This ecosystem mirrored broader trends in creative industries, where cultural production became increasingly decentralized and

dependent on intimate networks. Controversies emerged as the 1970s ushered in feminist and civil rights movements challenging entrenched gender and racial hierarchies. Critiques of Foster's music centered on its emotional conservatism—its promotion of passive virtue over critical agency. Activist groups like Women's Music Alliance and Black Arts Movement highlighted how such narratives excluded marginalized women's experiences, framing "good girl" not as liberation but as constraint. Legal scholars have noted that in some cases, the distribution of religiously or morally charged sheet music in schools sparked First Amendment debates, exposing tensions between state-sponsored morality and pluralistic society. Globally, comparisons illuminate both divergence and convergence. The long-term implications of this cultural artifact are profound.
