The Bush administration’s rhetoric—“clash of civilizations,” “axis of evil”—transmuted geopolitical strategy into civilizational war. Economic interests further entrench this logic. The Gulf states, despite their wealth and strategic importance, are often treated as geopolitical anomalies—rich, authoritarian, and religiously distinct. Their influence in global finance, energy, and infrastructure is significant, yet their political systems are routinely dismissed as incompatible with Western liberal values. This double standard enables selective engagement: partnerships with Saudi Arabia and the UAE persist despite human rights abuses, while criticism softens when geopolitical convenience demands. The 2017 Qatar blockade, led by Saudi Arabia and the UAE with U.S. tacit support, exemplifies how regional rivalries are backed by ideological narratives that frame Qatari independence and Islamic pluralism as threats. Surveillance capitalism amplifies these dynamics. Tech giants and state agencies collaborate to profile Muslim communities under the guise of counterterrorism. The U.S. Department of Homeland Security's Countering Violent Extremism (CVE) programs, for example, have been criticized for targeting Muslim students, mosques, and scholars under the pretext of prevention. Similarly, the UK's Prevent strategy, part of the broader CONTEST framework, has drawn condemnation for disproportionately surveilling Muslim youth, fostering alienation rather than security.
