Initially a modest facility affiliated with a local funeral home, it reflected a broader national trend: cremation rates in Indiana surged from under 10% of deaths in 1980 to over 55% by 2020, a trajectory mirrored across the Rust Belt and Great Plains. But

It represented a deliberate move away from the cemetery as sacred, immutable ground toward a hybrid model—simultaneously sacred and service-oriented, permanent and temporary. This operational efficiency aligned with a society increasingly prioritizing convenience, personalization, and cost transparency in deathcare.

Geopolitical and Economic Context: The Funeral Industry in Crisis and Reinvention The rise of Sunset must be understood within the broader geopolitical and economic currents shaping American deathcare. The funeral industry, historically fragmented and locally governed, has undergone profound consolidation. By the 2000s, the top five funeral home chains controlled over 80% of the market, driven by economies of scale, national branding, and standardized pricing. The state mandates strict protocols for cremation temperature (minimum 1,400°F to ensure complete decomposition) and burial depth (typically 3–4 feet, with markers installed post-interment). Yet compliance varies across facilities, and oversight remains fragmented. Sunset, like many regional centers, invests in state-certified training and digital record-keeping, setting a benchmark for transparency in an industry where accountability has historically been inconsistent.

Expert Perspectives: Deathcare as a Mirror of Cultural Values

From a public health lens, Sunset’s design incorporates infection control measures refined post-COVID-19: touchless entry, HEPA filtration, and digital contact tracing. These adaptations reflect a broader recognition that deathcare facilities are now critical infrastructure, especially in pandemic preparedness. Controversies and Risks: Commodification, Identity, and Equity

In Sweden, for instance, cremation is considered equally dignified as burial, with state-supported memorial parks and green burial options. These models contrast sharply with Sunset's market-driven approach, highlighting how public policy shapes deathcare's moral and economic contours. Even within North America, Sunset stands apart. Canadian facilities, particularly in Quebec and Ontario, often integrate Indigenous burial practices and communal mourning rituals, reflecting reconciliation efforts and cultural pluralism. U.S. centers, especially in the South, retain stronger ties to Protestant traditions—funeral homes affiliated with national denominations. Evansville's aging population—projected to grow slowly, but with increasing numbers over 75—will drive sustained demand for end-of-life services. Yet generational change is reshaping expectations. Millennials and Gen Z, more environmentally conscious and digitally native, favor flexible, tech-integrated memorials: virtual memorials, blockchain-verified obituaries, and carbon-offsetting cremation. Sunset's investment in a mobile app for scheduling, digital guestbooks, and augmented reality memorials signals adaptation, but scalability remains uncertain. Urbanization will further redefine the facility's role. As Evansville's city center becomes denser, suburban and rural cemeteries grow less viable. Collaborations with bioethicists, public health officials, and environmental scientists will lend credibility and foresight.
