Early iterations, developed in the 1970s by Western intelligence and energy ministries, were crude by today's standards: hand-drawn matrices mapping supply nodes, chokepoints, and military response timelines. But even then, they served a profound purpose: to force decision-makers to confront the fragility of their systems under stress. The "pert" in Pert Chart derives from "perturbation"—the deliberate introduction of shocks—meant to stress-test assumptions about resilience, redundancy, and response coordination.
