However, compliance costs remain prohibitive for many Eastern European labs, creating a de facto safety divide. China's approach reflects its rapid scientific ascent and centralized governance. The **National Standard for Laboratory Safety** (GB 17082-2018) mandates strict containment for high-risk biotech, with regular inspections by provincial health authorities. While compliance has improved, transparency remains a challenge. Independent audits are rare, and whistleblower protections are underdeveloped, raising concerns about underreporting. Yet China's state-driven investment in lab infrastructure—over \$12 billion annually—has enabled rapid scaling of safety protocols, particularly in CRISPR and AI-driven drug discovery. In India, laboratory safety testing operates within the **Occupational Safety and Health Act (1996)**, but implementation is uneven. While elite institutions in cities like Bangalore and Mumbai maintain international standards, rural and government labs often lack basic safety equipment. A 2023 report by the National Institute of Occupational Health revealed that only 14% of government-run biomedical labs in rural areas have functional biosafety cabinets. This disparity limits India's ability to lead in global health security, particularly amid rising zoonotic threats. Africa presents a

complex picture. The African Union’s *Science, Technology and Innovation Strategy for Africa (STISA-2024)* includes a safety component, promoting regional training hubs and standardized testing protocols. Yet funding gaps and political instability hinder progress. In South Africa, the *National Bioethics Committee* has advanced guidelines for dual-use research, but enforcement lags. Many labs rely on donor funding, creating sustainability challenges. These regional divergences reflect broader inequities in scientific capacity. High-income nations benefit from robust funding, advanced infrastructure, and regulatory maturity, enabling proactive safety cultures. Lower-income regions face systemic constraints—financing, trained personnel, and institutional stability—making compliance reactive rather than preventive. This imbalance not only endangers local researchers but threatens global biosecurity: a breach in an under-resourced lab can have transnational consequences. The response has been growing.
