Maxwell was among the first to treat data not as a supplement, but as a primary source: tax records, shipping logs, corporate registries, and encrypted communications. He

built a clandestine network of trusted sources across Africa, Latin America, and Southeast Asia—journalists, auditors, bureaucrats—who shared intelligence under layers of digital and physical security. This infrastructure allowed him to uncover patterns that individual reporters could never detect alone. In 1985, the “Silk Road Leak” investigation—revealing how multinationals routed profits through Hong Kong, Luxembourg, and the Cayman Islands—became a template for investigative coalitions, later inspiring the International Consortium of Investigative Journalists (ICIJ). His work during the Cold War era placed him at the nexus of geopolitics. In Eastern Europe, he infiltrated state-controlled media ecosystems by cultivating dissident correspondents and decrypting censored bulletins, exposing how information suppression sustained authoritarian rule. In South Africa, his reporting on apartheid-era arms deals with Israeli and British firms—published under pseudonyms during state surveillance—became critical evidence for international sanctions campaigns. In a 1997 report on human trafficking networks in Southeast Asia, his sourcing inadvertently exposed informants, leading to reprisals. The episode prompted a recalibration: deeper engagement with local civil society before publication, and the establishment of secure communication protocols.
