In East Asia, Japan's **shūshin kōryū** (lifetime employment) culture historically fused OPHI with organizational loyalty. Companies like Toyota maintained lifelong records that informed internal promotions and career planning, reinforcing social cohesion. However, demographic decline and the rise of remote work have strained this model, prompting Tokyo to adopt OPHI systems that support mobility across firms—a shift toward 'portable performance histories.' South Korea, meanwhile, has pioneered OPHI for gig workers, using platform-generated data to create portable records that follow labor across roles, offering a blueprint for inclusive labor governance. In Latin America, OPHI remains fragmented. Brazil's **Carreira Digital** initiative integrates occupational history into public employment services, aiming to reduce informality. Yet enforcement is uneven, and informal workers often lack access

may replicate existing inequities: women and minority workers are disproportionately flagged for ‘soft skills’ deficiencies, even when objective outcomes show parity. A 2022 study by the National Bureau of Economic Research found that OPHI-based hiring algorithms in tech firms reduced diversity by 18% compared to human-led reviews, due to ingrained linguistic and behavioral biases. Surveillance is another critical concern. As OPHI systems integrate biometrics—facial recognition, keystroke dynamics, and voice stress analysis—workers increasingly find themselves under digital scrutiny.
