In the Balkans, for example, competing national narratives use Catalogo entries to assert historical precedence—Montenegrin nobles citing 14th-century **b folle** to claim lineage, vs. Serbian archives emphasizing broader medieval unity. These uses expose the catalog's vulnerability to instrumentalization. Legal scholars emphasize that while **b folle** are not binding under international law, their preservation carries moral weight. The 2001 UNESCO Recommendation on the Preservation of Digital Heritage explicitly cites the Catalogo as a case study in safeguarding "intangible political memory," warning against the erasure of marginalized sovereignties from collective consciousness. Yet, enforcement remains weak. Digital obsolescence, fragile physical media, and inconsistent archival policies threaten the catalog's long-term survival. Yet, the Italian catalog stands unique in its granular focus on micro-states and its fusion of legal rigor with narrative depth. In contrast to the grand narratives of nation-building, the *Catalogo* reveals a world of overlapping loyalties, contested borders, and bureaucratic improvisation. It parallels modern phenomena: the rise of sub-state movements, the digital archiving of contested histories, and the increasing politicization of historical memory. Just as the catalog captures vanished states, today's digital platforms preserve ephemeral identities—from blockchain-based micronations to decentralized autonomous organizations (DAOs) experimenting with new forms of governance.
