Instead, he introduced the wave-particle duality through familiar phenomena: the diffraction of light through a double slit as a ripple in water, or the quantization of energy via blackbody radiation framed as a thermal dance of oscillators. By grounding Planck's quantum hypothesis in thermodynamic reasoning, he

made the discontinuity in energy exchange intuitive. Students were not asked to accept wavefunctions as abstract entities, but to appreciate them as extensions of classical probability—governed by the same conservation laws that govern a rolling ball. This epistemological bridge was crucial: it preserved the continuity between classical and quantum domains, preventing the cognitive dissonance that often alienates learners. Relativity followed a similar trajectory. In Part 2, Verma revisited special relativity not as a set of Lorentz transformations, but as a reimagining of simultaneity and causality.
